**TERMS AND CONDITIONS**

⇨ Please read form carefully ⇩

- **Horses will not be allowed through the ring until consignor has checked in at the Sale Office.** Tags are to be picked up when Registration papers are turned in at the Sale Office.
- A vet certificate will be required on all scratched horses. No refunds on scratched horses.
- No horses allowed in yards that are not consigned to the sale.
- Not responsible for any accidents to person(s) or horse(s).
- **ABSOLUTELY NO ALLEY TRADING. All horses must be tagged and sold through the ring.**

1. **Consignment Fee - \$75.00 per head.** Make cheque payable to *Rocking W Horse Sales* and forward along with your consignment forms.
2. **8% commission on each sale or minimum commission of \$75.00 per head, whichever is highest. New for 2010 Foals Only** - Minimum commission of \$35.00 will be charged, in lieu of a pass out fee.
  - \* If a horse is consigned to the sale and is not brought to the sale, we will require a vet certificate stating the reason why the horse can not be sold. We reserve the right to impose a fine of \$300.00 if the consignor in question does not comply with this condition. *In order to protect the credibility of our consignors and this sale, this rule will be enforced.*
3. No refunds of consignment fees.
4. Sale position will be determined by the Rocking W Horse Sales management.
5. Horse(s) will be sold in catalog order.
6. Consignors guarantee that each consignment is:
  - a) sound of eyes, wind and limb
  - b) not a cribber
  - c) has not been nerved or have navicular disease
  - d) is not a cryptorchid or a ridgeling
  - e) is not a parrot mouth
7. All registration papers (see enclosed Consignor's Checklist) and consignment fee must accompany consignment form.
  - \* If the paperwork on a horse is not in order, we reserve the right to withhold the purchase price of the horse until all the paperwork has been processed and sent to the Rocking W Horse Sales.
  - \* For foals whose registration papers have been applied for but not received, you must include a signed transfer with your consignment form.
  - \* Foals Sold on Application – Buyer will be responsible for completing transfers and application forms.
8. Buyer to pay one (1) transfer fee. If the horse in question has not been transferred to the consignor, the consignor must include a cheque or money order payable to the appropriate Association for the first transfer fee.
9. \$15.00 yardage fee will be charged on all horses.
10. A preview of performance horses will be held on Friday, September 3.
11. **Consignors MUST be present** to put their horses through the ring.
12. We reserve the right to limit the total number of horses consigned to the sale.

## PAPERS REQUIRED FOR SALE DAY

### ALL REGISTERED HORSES:

- ▶ **Registration** papers
- ▶ **Signed Transfer**
  - If the horse has not been transferred to you, remember to include the original Transfer and a signed open Transfer for this sale. Also include a cheque or money order, payable to the appropriate Association, for the first Transfer.
  - In the section "Consigned to auction sale" on the Transfer form, include "Rocking W Horse Sales, Box 848, Morden, MB R6M 1A8" and the date of the sale.

### REGISTERED BRED MARES:

- ▶ Signed Statement from you vet no earlier than 3 weeks prior to the sale confirming that she is bred
- ▶ DNA number on **Mare's Registration Paper**
- ▶ Copy of **Stud's Registration Paper** to show his **DNA number**
- ▶ Signed handwritten **Breeders Certificate** for 2011 foal
- ▶ **Registration Papers**
- ▶ **Signed Transfer**

### REGISTERED FOALS (PAPERS APPLIED FOR):

- ▶ **Registration** papers
- ▶ **Signed Transfer**
- ▶ If you have applied for foals' registration papers and have not yet received them, include a signed Transfer.
  - When you receive the registration papers, please forward them immediately to the Rocking W Horse Sales so they can be forwarded to the buyer.

### FOALS SOLD ON APPLICATION:

- ▶ **Breeders' Certificate** filled out in full detail with CORRECT signatures where needed
- ▶ **Signed Transfer**
- ▶ Copy of **Dam's Registration Paper with DNA number** on it
- ▶ Copy of **Stud's Registration Paper with DNA number** on it.

**No pending papers allowed on horses 1 year and older. Owner must have original copy of permanent registry**
